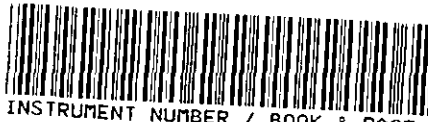

Article 13-1 Indigenous peoples have the right to revitalize, use, develop and transmit to future generations their histories, languages, oral traditions, philosophies, writing systems and literatures, and to designate and retain their own names for communities, places and persons 2 States shall take effective measures to ensure that this right is protected and also to ensure that indigenous peoples can understand and be understood in political, legal and administrative proceedings, where necessary through the provision of interpretation or by other appropriate means



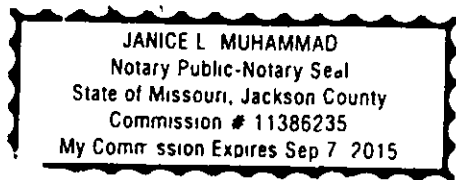

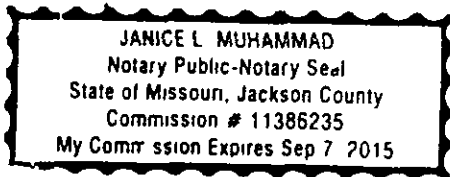

United Nations Universal Declaration of Human Rights

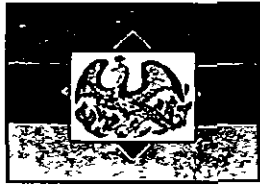
Article (15) (1) Everyone has the right to a nationality (2) No one shall be arbitrarily deprived of his nationality nor denied the right to change his nationality

United Nations Declaration of the Rights of Indigenous Peoples

Article (5) Every indigenous individual has the right to a nationality Article (8) Indigenous peoples have the collective and individual right to maintain and develop their distinct identities and characteristics, including the right to identify themselves as indigenous and to be recognized as such Article (9) Indigenous peoples and individuals have the right to belong to an indigenous community or nation in accordance with the traditions and customs of the community or nation concerned No disadvantage of any kind may arise from the exercise of such a right

INTER-AMERICAN DECLARATION ON THE RIGHTS OF INDIGENOUS PEOPLE - Draft approved by the IACHR at the 1278 session held on September 18, 1995

SECTION ONE 'INDIGENOUS PEOPLES'

Art 1 Definition

1 In this Declaration indigenous peoples are those who embody historical continuity with societies, which existed prior to the conquest and settlement of their territories by Europeans (Alternative 1) [, as well as peoples brought involuntarily to the New World who freed themselves and re-established the cultures from which they have been torn] (Alternative 2) [, as well as tribal peoples whose social, cultural and economic conditions distinguish them from other sections of the national community and whose status is regulated wholly or partially by their own customs or traditions or by special laws or regulations

2 Self identification as indigenous or tribal shall be regarded as a fundamental criterion for determining the groups to which the provisions of this Declaration apply

3 The use of the term "peoples" in this instrument shall not be construed as having any implication with respect to any other rights that might be attached to that term in international law

INDIGENOUS AND TRIBAL PEOPLES CONVENTION, 1989 (No. 169) Adopted on 27 June 1989 by the General Conference of the International Labour Organization at its seventy-sixth session Entry into force 5 September 1991 Article 8,

1 In applying national laws and regulations to the peoples concerned, due regard shall be had to their customs or customary laws

2 These peoples shall have the right to retain their own customs and institutions, where these are not incompatible with fundamental rights defined by the national legal system and with internationally recognized human rights Procedures shall be established, whenever necessary, to resolve conflicts which may arise in the application of this principle

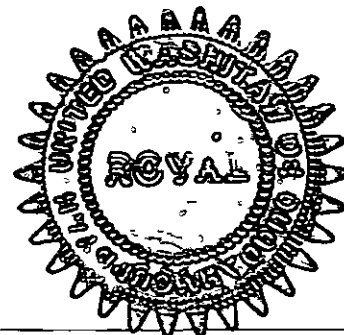
