You are further directed to inform the law enforcement agent serving this warrant of the account balances and/or value of the assets affected by this warrant.

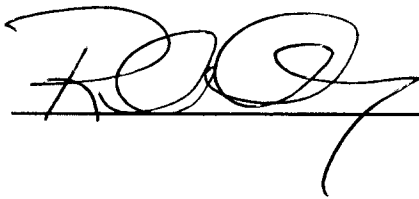

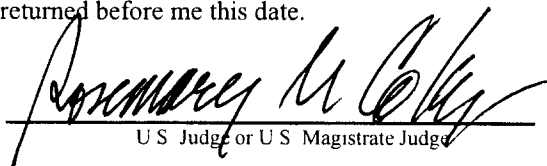
